The tenure of traineeship is for a period of one year and extendable annually for four years (Total five years of traineeship) subject to satisfactory performance of the candidate and requirement to the Project assessed annually. You are liable to be posted anywhere in India as per the requirement of the Institute.
3. There will be annual increase of Rs. 2,500/- in the remuneration based on satisfactory performance.
4. The date of determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed applications.
5. It is open to the Institute to conduct written test to shortlist the candidates for interview in case the attendance of candidates is more.
6. Age relaxation is permissible to SC, ST & OBC candidates and also to physically handicapped candidate as notified by Government of India from time to time.
