ELIGIBILITY CRITERIA:

1. The candidate should have passed 4-year BE/ B. Tech in above mentioned branches recognized by AICTE or GOI on or after 01/07/2022.
2. The candidate should have passed 3-year BBA/BBM/BBS (Optional Trade) in above mentioned recognized by AICTE or GOI on or after 01/07/2022.
3. Candidate's upper age limit is 25 years. Relaxation of 5 years for SC & ST candidates. Relaxation of 3 years for OBC candidates and 10 years for Persons with disabilities.
4. Age Limit: Maximum Age Limit 21 years as on 01.11.2025 (Upper age limit is relatable by 5 years for SC/ST, 3 years for OBC candidate).
5. Minimum Percentage in Graduation for General & OBC candidates should be 60% & above. For SC/ST candidates minimum Percentage in Graduation should be 40% & above.
6. Candidates who have undergone or undergoing Apprenticeship Training under NATS in any **other establishment/ organization are strictly not eligible.**
7. Candidates who have acquired or pursuing higher qualifications are not eligible
8. Candidates who do not possess Degree/ Provisional Degree certificate are not eligible.

NATS2.0 PORTAL PROCESS FOR REGISTRATION: -

- Step 1: Log on to NATS2.0 portal (<https://nats.education.gov.in>)
- Step 2: Click on 'Student' tab.
- Step 3: Click on 'Student Register'
- Step 4: Ensure the listed documents for student enrolment (Direct Link: <https://nats.education.gov.in/student/register.php>)
- Step 5: Click on 'Yes'
- Step 6: Enter Email and Mobile No. (Will be used as a Username for Log-In Purpose) and captcha displayed in the screen.
- Step 6: Click on Send OTP button (OTP will be sent to the above entered Mobile No. & Email)
- Step 7: Enter both OTPs received through Email and Mobile and Click on 'Verify OTP'
- Step 8: Fill in all the required details (Basic details, education details, communication information, training preference & Bank details).
- Step 9: Profile preview and Click on Final Submit.
- Step 10: Take print out of the registration form.

➤ OPTIONAL TRADE (BBA/BBM/ BBS)

Monthly stipend is 12,500/- (Rupees Twelve Thousand & Five Hundred). Out of 12,500/- stipend amount:

- 8,000/- will be paid by BEL
- 4,500/- will be paid by Govt. through Direct Benefit Transfer (DBT)

SELECTION PROCESS:

1. Selection is purely on the basis of merit based on marks secured in the written test.
2. Shortlisted candidates will be informed through E-Mail only.

OTHER INFORMATION:

- Candidates who fulfill the above conditions only need to attend written test / selection.
- The duration of the Apprenticeship Training is ONE year.
- No TA/DA will be provided to the candidates for attending the written test.
